SR 9A/I-95 FROM NW 29 ST TO NW 131 ST

CONTRACTOR HAS COMPLETED ALL MAJOR CONCRETE REPLACEMENT OPERATIONS AND IS CURRENTLY WORKING ON SEALING BRIDGE JOINTS, PLACING PERMANENT STRIPING AND GENERAL PUNCH LIST ITEMS

LANE CLOSURES:

- WEDNESDAY, APRIL 22 - Up to four I-95 northbound general-purpose lanes will be closed from NW 29 Street to NW 53 Street between the hours of 8 p.m. and 8 a.m. Two lanes will be closed at 8 p.m., and the remaining lanes will be closed at 10 p.m.
- WEDNESDAY, APRIL 22 - Up to four southbound I-95 general-purpose lanes will be closed from NW 79 Street to NW 29 Street between the hours of 8 p.m. and 8 a.m. Two lanes will be closed at 8 p.m., and the remaining lanes will be closed at 10 p.m.
- THURSDAY, APRIL 23 AND FRIDAY, APRIL 24 - Up to two I-95 northbound general-purpose lanes will be closed from NW 46 Street to NW 79 Street between the hours of 8 p.m. and 8 a.m. on Thursday, and between the hours of 9 p.m. and noon on Friday.
- THURSDAY, APRIL 23 AND FRIDAY, APRIL 24 - The northbound 95 Express Lanes will be closed from SR 112 to the Golden Glades Interchange between the hours of 8 p.m. and 8 a.m.
- THURSDAY, APRIL 23 AND FRIDAY, APRIL 24 - Up to two southbound I-95 general-purpose lanes will be closed from NW 79 Street to NW 29 Street between the hours of 8 p.m. and 8 a.m. on Thursday and between the hours of 9 p.m. and noon on Friday.
- THURSDAY, APRIL 23 AND FRIDAY, APRIL 24 - The southbound 95 Express Lanes will be closed from the Golden Glades Interchange to SR 112 between the hours of 8 p.m. and 8 a.m.

DETOURS:

- WEDNESDAY, APRIL 22 - The northbound I-95 exit ramp to NW 79 Street/NW 81 Street will be intermittently closed between the hours of 8 p.m. and 8 a.m.
DETOUR:
 - Exit at NW 95 Street, make a left at NW 95 Street
 - Turn left at NW 7 Avenue to connect with NW 79 Street
- WEDNESDAY, APRIL 22 - The NW 79 Street/NW 81 Street ramp to southbound I-95 will be closed between the hours of 8 p.m. and 8 a.m.
DETOUR:
 - Go south on NW 7 Avenue
 - Turn left on NW 62 Street to access the southbound I-95 ramp

- WEDNESDAY, APRIL 22 AND THURSDAY, APRIL 23 - The northbound I-95 ramps to westbound SR 112 and eastbound I-195 will be closed between the hours of 8 p.m. and 8 a.m. on Wednesday and Thursday, and between the hours of 9 p.m. and noon on Friday.
DETOUR:
- Continue north on I-95 and exit at NW 62 Street
- Turn left at NW 62 Street, then go south on I-95 to access the ramps to SR 112 and I-195
- WEDNESDAY, APRIL 22 - The eastbound SR 112 and westbound I-195 ramps to northbound I-95 will be closed between the hours of 8 p.m. and 8 a.m.
DETOUR:
- Go south on I-95, exit at NW 8 Street, then turn left on NW 8 Street
- Turn left on NW 3 Avenue to access I-95 north
- THURSDAY, APRIL 23 AND FRIDAY, APRIL 24 - The eastbound SR 112 and westbound I-195 ramps to southbound I-95 will be closed between the hours of 8 p.m. and 8 a.m. on Wednesday and Thursday, and between the hours of 9 p.m. and noon on Friday.
DETOUR:
- Continue north on I-95 and exit at NW 62 Street
- Turn left at NW 62 Street to access the southbound I-95 ramp

SR A1A/MACARTHUR CAUSEWAY EAST BRIDGE (BRIDGE NUMBER 870077) FROM TERMINAL ISLE TO ALTON ROAD

LANE CLOSURES:

- Two eastbound or two westbound lanes may be closed between 7 a.m. to 7 p.m. for substructure repairs.

SR A1A/MACARTHUR CAUSEWAY AT SR 907/ALTON ROAD

LANE CLOSURES:

- A partial lane closure of the eastbound MacArthur Causeway right turn lane onto southbound Alton Road will be necessary for one day from 9 a.m. to 3:30 p.m. along eastbound MacArthur Causeway when approaching Alton Road. This closure will allow crews to finalize the work. An exact date for this operation is pending to be determined.
- A flashing beacon has been installed along eastbound MacArthur Causeway when approaching Alton Road. The flashing beacon activates and alerts drivers when the traffic signal located at Alton Road is red for eastbound MacArthur Causeway traffic.

SR A1A/SR A1A/MACARTHUR CAUSEWAY AT FOUNTAIN STREET

LANE CLOSURES:

- A temporary single lane closure will be necessary for one day from 9 a.m. to 3:30 p.m. along MacArthur Causeway when approaching Fountain Street. This closure will allow crews to finalize the work. The exact date for this operation is pending to be determined.

- Flashing beacons are being installed along eastbound and westbound MacArthur Causeway when approaching Fountain Street. Once the project is complete, the flashing beacons activate and alert drivers when the traffic signal located at Fountain Street is red for eastbound and westbound MacArthur Causeway traffic.

INDIAN CREEK DRIVE FLOODING MITIGATION PROJECT

LANE CLOSURE

- Indian Creek Drive continues to be closed to general traffic between 41 Street and 31 Street while the contractor installs underground drainage and rebuilds the roadway. Southbound traffic is being routed to Collins Avenue in this area. Collins Avenue has been modified to provide one northbound and one southbound travel lane. This traffic pattern is expected to last about one year.
- One southbound lane on Indian Creek Drive is closed during daytime hours between 28 Street and 26 Street while the contractor performs drainage and sidewalk work. One lane will remain open at all times. A pedestrian detour will be set up as needed during the work. This work is expected to last several weeks.

SR 934/NORMANDY DRIVE AT RUE GRANVILLE & FROM RUE VERSAILLES TO BAY DRIVE

DETOURS:

- Starting TUESDAY, MARCH 31, 2020 THROUGH JUNE 2020, the Florida Department of Transportation (FDOT) will be continuously closing the U-turn movement from eastbound 71 Street to westbound SR 934/Normandy Drive in order to perform the reconstruction of the new raised median.
DETOUR:
- Motorists traveling on eastbound 71 Street will be detoured north on Bay Drive, west on Marseille Drive and south on Rue Versailles in order to access westbound SR 934/Normandy Drive.

I-395 RECONSTRUCTION PROJECT

LANE CLOSURES:

- Starting on Tuesday night, April 21, up to four lanes on southbound I-95 will be closed from SR 112 to just south of NW 20 Street between the hours of 8 p.m. and 8 a.m. on the following day. At 6 a.m., one of the four lanes will reopen, and three lanes will remain continuously closed (24 hours a day/seven days a week). The southbound 95 Express Lanes from the Golden Glades Interchange to SR 112 will also be closed between the hours of 8 p.m. and 6 a.m. The nighttime lane closures and closure of the 95 Express Lanes will occur Monday through Saturday.

This expanded lane closure schedule is expected to be implemented for a period of approximately four weeks and will be adjusted as needed.

- TUESDAY, APRIL 21 - One of the two lanes on the westbound I-395 ramp to northbound I-95 will be closed for a period of approximately eighteen (18) months to allow the contractor to reconstruct sections of I-95 where the SR 836 and I-395 ramps enter northbound I-95.

- MONDAY MORNING, APRIL 20 (TUESDAY MORNING, APRIL 21 IS AN ALTERNATE DATE) - All westbound SR 836 travel lanes will be shifted to the left side of the roadway from the Miami River to east of NW 17 Avenue to allow the contractor to continue construction activities on the right side of the roadway.
- FRIDAY, APRIL 17 AND SATURDAY, APRIL 18 AND MONDAY, APRIL 20 THROUGH FRIDAY, APRIL 24 - Up to three lanes on northbound I-95 from NW 8 Street to NW 29 Street will be closed between the hours of 8 p.m. and 8 a.m.
- SATURDAY, APRIL 18 AND SUNDAY, APRIL 19 THROUGH FRIDAY, APRIL 24 - One lane on mainline eastbound I-395 will be closed from I-95 to Biscayne Boulevard between the hours of 10 p.m. and 5:30 a.m.
- SATURDAY, APRIL 18 AND SUNDAY, APRIL 19 THROUGH FRIDAY, APRIL 24 - One lane on mainline westbound I-395 will be closed from I-95 to Biscayne Boulevard between the hours of 10 p.m. and 5:30 a.m.
- FRIDAY, APRIL 17 AND SUNDAY, APRIL 19 THROUGH FRIDAY, APRIL 24 - Two lanes on eastbound SR 836 from NW 20 Avenue to east of NW 17 Avenue will be closed every day between the hours of 8 p.m. and 6:30 a.m. One lane will remain closed 24/7.
- FRIDAY, APRIL 17 AND SUNDAY, APRIL 19 THROUGH FRIDAY, APRIL 24 - Two westbound lanes on SR 836 from I-95 to NW 17 Avenue will be closed between the hours of 8 p.m. and 8 a.m.

DETOURS:

- MONDAY, APRIL 20 THROUGH FRIDAY, APRIL 24 - The westbound I-395 ramps to northbound I-95 will be closed between the hours of 8 p.m. and 6 a.m.
DETOUR:
 - Access the southbound I-95 ramp
 - Exit at SW 7 Street/Brickell Avenue (Exit 1B), then turn left at SW 8 Street
 - Enter the northbound I-95 ramp, then continue north on I-95
- MONDAY, APRIL 20 THROUGH FRIDAY, APRIL 24 - The eastbound SR 836 ramp to northbound I-95 will be closed between the hours of 9 p.m. and 6 a.m.
DETOUR:
 - Access the NW 8 Street ramp, then exit at the NW 8 Street/PortMiami ramp
 - Turn left at NW 8 Street
 - Turn left at NW 3 Avenue to access the northbound I-95 ramp
