INDIAN CREEK DRIVE FLOODING MITIGATION PROJECT

LANE CLOSURE:

- Work is underway along Collins Avenue between 25 Street and 27 Street. Motorists will only be able to travel northbound on Collins Avenue in this area. Drivers traveling south will be directed to turn east on 27 Street and continue south on Indian Creek Drive.
- Beginning Friday, May 14, Indian Creek Drive will be closed to general traffic between 41 Street and 26 Street. Southbound traffic will be routed to Collins Avenue in this area. Collins Avenue has been modified to provide one northbound and one southbound travel lane. This traffic pattern is expected to last several months.
- Traffic signage, barricades and temporary signals on Collins Avenue have been installed as part of the extended traffic plan. Ingress and egress for surrounding properties will be maintained throughout this process. Pedestrian crossings have been installed throughout the corridor as well as U-Turn opportunities at certain locations.
- Buildings along Indian Creek Drive will continue to have access through the work zone.
- North facing parking spaces on the west side of Collins Avenue between 26 Street and 31 Street will be temporarily removed and later reestablished as southbound parking spaces.

SR 112/I-195/JULIA TUTTLE CAUSEWAY FROM EAST OF SR 5/US 1/BISCAYNE BOULEVARD TO SR 907/ALTON ROAD

LANE CLOSURES:

- No lane closures are anticipated for the week of November 8, 2021
- On Monday, November 15, 2021, the westbound and/or eastbound outside shoulder lane will be closed between 9 p.m. and 5 a.m.

SR A1A/COLLINS AT THE INTERSECTIONS OF 10, 11, 14 AND 74 STREET

LANE CLOSURES:

- At least one lane of SR A1A/Collins Avenue, in either direction, will be closed (as needed) at the intersections of 10, 11, 14 and 74 Street, between the hours of 9 a.m. and 3:30 p.m., Monday, November 15, 2021 through Friday, December 31, 2021.

I-395 RECONSTRUCTION PROJECT

LANE CLOSURES:

- FRIDAY, JANUARY 14 AND SUNDAY, JANUARY 16 THROUGH FRIDAY, JANUARY 21 - Up to two lanes on southbound I-95 from NW 29 Street to NW 8 Street will be closed between the hours of 9 p.m. and 5:30 a.m. The closures on Fridays will occur between the hours of 11 p.m. and 11 a.m.
- FRIDAY, JANUARY 14 AND SUNDAY, JANUARY 16 THROUGH FRIDAY, JANUARY 21 - Up to two lanes on northbound I-95 will be closed nightly from NW 8 Street to NW 29 Street between the hours of 9 p.m. and 5:30 a.m. The closures on Fridays will occur between the hours of 11 p.m. and 11 a.m.
- FRIDAY, JANUARY 14 AND SUNDAY, JANUARY 16 THROUGH FRIDAY, JANUARY 21 - Up to two lanes on eastbound SR 836 from NW 17 Avenue to I-95 will be closed as needed between the hours of 9 p.m. and 5:30 a.m.
- FRIDAY, JANUARY 14 AND SUNDAY, JANUARY 16 THROUGH FRIDAY, JANUARY 21 - Up to two westbound lanes on SR 836 from I-95 to NW 17 Avenue will be closed as needed between the hours of 9 p.m. and 5:30 a.m.
- FRIDAY, JANUARY 14 AND SUNDAY, JANUARY 16 THROUGH FRIDAY, JANUARY 21 - One lane on mainline eastbound I-395 will be closed from I-95 to Biscayne Boulevard between the hours of 10 p.m. and 5:30 a.m.
- FRIDAY, JANUARY 14 AND SUNDAY, JANUARY 16 THROUGH FRIDAY, JANUARY 21 - Up to two lanes on mainline westbound I-395 will be closed from Biscayne Boulevard to I-95 between the hours of 10 p.m. and 5:30 a.m.

DETOURS:

- The North Bayshore Drive ramp to the eastbound MacArthur Causeway has been closed to allow for the construction of the Signature Bridge and the new permanent ramp. Drivers can use a new signalized left-turn lane on southbound Biscayne Boulevard that will provide access to the eastbound MacArthur Causeway ramp at NE 11 Terrace adjacent to the Frost Museum. This traffic pattern will remain in effect until 2024.
- The westbound I-395 ramp to northbound I-95 has been shifted from the right side of the roadway to the left side. Drivers on westbound I-395 will need to stay to the left to access the new single lane ramp. Variable Message Signs (VMS) will direct drivers going west on I-395 who want to go north on I-95 to the new temporary ramp. The temporary ramp will be in place for approximately 16 months while workers build a new permanent two-lane ramp and other I-395 bridges.

- TUESDAY, JANUARY 18 AND THURSDAY, JANUARY 20 - The westbound I-395 ramp to northbound I-95 will be closed between the hours of 10 p.m. and 5:30 a.m. Drivers can:

DETOUR

- Access the southbound I-95 ramp
- Exit at SW 7 Street/Brickell Avenue (Exit 1B), then turn left at SW 8 Street
- Enter the northbound I-95 ramp, then continue north on I-95

- FRIDAY, JANUARY 14 AND MONDAY, JANUARY 17 THROUGH FRIDAY, JANUARY 21 - The eastbound SR 836 ramp to northbound I-95 will be closed between the hours of 9 p.m. and 5:30 a.m. Drivers can:

DETOUR

- Access the southbound I-95/NW 8 Street ramp, then exit at the NW 8 Street/PortMiami ramp
- Turn left at NW 8 Street
- Turn left at NW 3 Avenue to access the northbound I-95 ramp

- FRIDAY, JANUARY 14 - The northbound I-95 ramp to westbound SR 836 will be closed between the hours of 11:45 p.m. and 5:30 a.m.

Drivers can:

- Enter the eastbound I-395 ramp
- Exit at NE 2 Avenue/Biscayne Boulevard (Exit 2B), then turn right on NE 2 Avenue
- Turn right on NE 11 Street
- Turn right on NE 1 Avenue to access westbound I-395 to continue onto westbound SR 836
