LANE CLOSURE ALERT

I-95 CLOSURES

- WEDNESDAY, APRIL 24, THURSDAY, APRIL 25 AND MONDAY, APRIL 29 THROUGH THURSDAY, MAY 2 Three lanes on northbound and southbound I-95 from NW 17 Street to NW 29 Street will be closed between the hours of 9 p.m. and 5:30 a.m. to allow the contractor to work in the median. The first lane will be closed at 9 p.m. and the second and third lanes will be closed at 10 p.m.
- FRIDAY, APRIL 26 AND SATURDAY, APRIL 27 Three lanes on northbound and southbound I-95 from NW 17 Street to NW 29 Street will be closed between the hours of 11 p.m. and 11 a.m.

NW 17 AVENUE FLAGGING OPERATION

 WEDNESDAY, APRIL 24 THROUGH FRIDAY, APRIL 26 AND MONDAY, APRIL 29 THROUGH FRIDAY, MAY 3 - There will be intermittent flagging operations on the eastbound SR 836 ramp to northbound NW 17 Avenue and the NW 17 Avenue ramp to westbound SR 836. The ramps will be momentarily closed at times between the hours of 7 a.m. and 3 p.m. to allow for the movement of equipment/materials to the area inside the ramp.

SR 836 CLOSURES

 WEDNESDAY, APRIL 24, THURSDAY, APRIL 25 AND MONDAY, APRIL 29 THROUGH THURSDAY, MAY 2 - One eastbound lane on SR 836 from NW 27 Avenue to NW 12 Avenue will be closed between the hours of 8 p.m. and 5:30 a.m. in order to allow for delivery of materials.

DETOUR ALERT

NW 20 STREET DETOUR

WEDNESDAY, MAY 1 THROUGH SATURDAY, MAY 4 - NW 20 Street will be closed from NW 7 Avenue to NW 3 Avenue between the hours of 10 p.m. and 5:30 a.m. Closures on Friday and Saturday will be between the hours of 11 p.m. and 7 a.m.

DRIVERS ON EASTBOUND NW 20 STREET CAN:

- Turn right on NW 7 Avenue
- Turn left on NW 17 Street
- Turn left on NW 3 Avenue to access NW 20 Street

DRIVERS ON WESTBOUND NW 20 STREET CAN:

- Turn left on NW 3 Avenue
- Turn right on NW 17 Street
- Turn right on NW 7 Avenue to access NW 20 Street

NOTE: Only local traffic will be allowed between NW 3 Avenue and I-95 and NW 7 Avenue and I-95. Vehicular traffic will not be permitted to pass under the I-95 overpass. This work will allow the contractor to remove portions of the median barrier wall on I-95.

Please note that this schedule may change due to bad weather or other unforeseen conditions.

The work is part of the I-395/SR 836/I-95 Design-Build Project that will reconstruct the I-395 corridor from the SR 836/I-395/I-95 (Midtown) Interchange to the MacArthur Causeway Bridge, including the construction of a Signature Bridge over NE 2 Avenue and Biscayne Boulevard; double-deck SR 836 from west of NW 17 Avenue to the Midtown Interchange and the replacement of the concrete pavement on I-95 from NW 8 Street to NW 29 Street.
