## **SR A1A/MACARTHUR CAUSEWAY EAST BRIDGE (BRIDGE NUMBER 870077) FROM TERMINAL ISLE TO ALTON ROAD**

FIN #: 436522-1-52-01

### **LANE CLOSURES:**

- One eastbound or one westbound lane may be closed as needed during daytime work hours between 7 a.m. and 7 p.m.
- Two westbound and/or two eastbound lanes will be closed Monday through Thursday nights between 10 p.m. and 7 a.m.

## **SR A1A/MACARTHUR CAUSEWAY AT SR 907/ALTON ROAD**

### **LANE CLOSURES:**

- A partial lane closure of the eastbound MacArthur Causeway right turn lane onto southbound Alton Road will be necessary for one day from 9 a.m. to 3:30 p.m. along eastbound MacArthur Causeway when approaching Alton Road. This closure will allow crews to finalize the work. An exact date for this operation is pending to be determined.
- A flashing beacon has been installed along eastbound MacArthur Causeway when approaching Alton Road. The flashing beacon activates and alerts drivers when the traffic signal located at Alton Road is red for eastbound MacArthur Causeway traffic.

## **SR A1A/SR A1A/MACARTHUR CAUSEWAY AT FOUNTAIN STREET**

### **LANE CLOSURES:**

- A temporary single lane closure will be necessary for one day from 9 a.m. to 3:30 p.m. along MacArthur Causeway when approaching Fountain Street. This closure will allow crews to finalize the work. The exact date for this operation is pending to be determined.
- Flashing beacons are being installed along eastbound and westbound MacArthur Causeway when approaching Fountain Street. Once the project is complete, the flashing beacons activate and alert drivers when the traffic signal located at Fountain Street is red for eastbound and westbound MacArthur Causeway traffic.

## INDIAN CREEK DRIVE FLOODING MITIGATION PROJECT

### LANE CLOSURE

- Indian Creek Drive continues to be closed to general traffic between 41 Street and 31 Street while the contractor installs underground drainage and rebuilds the roadway. Southbound traffic is being routed to Collins Avenue in this area. Collins Avenue has been modified to provide one northbound and one southbound travel lane. This traffic pattern is expected to last about one year.
- One southbound lane on Indian Creek Drive is closed during daytime hours between 28 Street and 26 Street while the contractor performs drainage and sidewalk work. One lane will remain open at all times. A pedestrian detour will be set up as needed during the work. This work is expected to last several weeks.

## SR 934/NORMANDY DRIVE AT RUE GRANVILLE & FROM RUE VERSAILLES TO BAY DRIVE

### DETOURS:

- Starting TUESDAY, MARCH 31, 2020 THROUGH JUNE 2020, the Florida Department of Transportation (FDOT) will be continuously closing the U-turn movement from eastbound 71 Street to westbound SR 934/Normandy Drive in order to perform the reconstruction of the new raised median.  
DETOUR:  
- Motorists traveling on eastbound 71 Street will be detoured north on Bay Drive, west on Marseille Drive and south on Rue Versailles in order to access westbound SR 934/Normandy Drive.
- Beginning THURSDAY, MAY 7 THROUGH MAY 8, 2020, between the hours of 7 a.m. and 4 p.m., the Florida Department of Transportation (FDOT) will be performing repaving operations along SR 934/Normandy Drive at the intersection of Rue Granville. During the paving operations, crews will continue to maintain travel lanes along SR 934/Normandy Drive, while periodically closing them to perform the work safely. No detours will be implemented at this time.

## I-395 RECONSTRUCTION PROJECT

### LANE CLOSURES:

- FRIDAY, JULY 3 AND MONDAY, JULY 6 THROUGH MONDAY, JULY 13 - Up to four lanes on northbound I-95 will be closed nightly from north of SR 836 to NW 29 Street between the hours of 8 p.m. and 5:30 a.m. One outside, northbound lane between NW 23 Street and NW 29 Street will remain continuously closed until 5:30 a.m. on Friday, July 3, and will close again at 8 p.m. on Monday, July 6 until 5:30 a.m. on Monday, July 13. Exit 4A to I-195 east will also remain continuously closed until 5:30 a.m. on Friday, July 3, and will close again at 8 p.m. on Monday, July 6 until 5:30 a.m. on Monday, July 13. Drivers can continue north on I-95 and access Exit 4B to go east on I-195.
- MONDAY, JULY 6 THROUGH FRIDAY, JULY 10 - Up to four lanes on southbound I-95 from NW 29 Street to NW 8 Street will be closed between the hours of 8 p.m. and 5:30 a.m.
- MONDAY, JULY 6 THROUGH FRIDAY, JULY 10 - One lane on mainline eastbound I-395 will be closed from I-95 to Biscayne Boulevard between the hours of 10 p.m. and 5:30 a.m.

- MONDAY, JULY 6 THROUGH FRIDAY, JULY 10 - One lane on mainline westbound I-395 will be closed from I-95 to Biscayne Boulevard between the hours of 10 p.m. and 5:30 a.m.
- MONDAY, JULY 6 THROUGH FRIDAY, JULY 10 - Two lanes on eastbound SR 836 from NW 20 Avenue to east of NW 17 Avenue will be closed between the hours of 8 p.m. and 5:30 a.m.
- MONDAY, JULY 6 THROUGH FRIDAY, JULY 10 - Two westbound lanes on SR 836 from I-95 to NW 17 Avenue will be closed between the hours of 8 p.m. and 6 a.m. One lane will remain closed between the hours of 6 a.m. and 2 p.m. from I-95 to the Miami River.

### DETOURS:

- MONDAY, JULY 6 THROUGH FRIDAY, JULY 10 - The eastbound SR 836 ramp to northbound I-95 will be closed between the hours of 9 p.m. and 5:30 a.m.  
DETOUR:
  - Access the NW 8 Street ramp, then exit at the NW 8 Street/PortMiami ramp
  - Turn left at NW 8 Street
  - Turn left at NW 3 Avenue to access the northbound I-95 ramp
- MONDAY, JULY 6 THROUGH FRIDAY, JULY 10 - The southbound I-95 ramp to NW 8 Street will be closed between the hours of 9 p.m. and 5:30 a.m.  
DETOUR:
  - Continue south on I-95, then exit at the SW 7 Street/Brickell Avenue (Exit 1B) ramp
  - Continue to SW 8 Street, then turn left to access the northbound I-95 ramp
  - Continue north on I-95 and exit at the NW 2 Street/Arena (Exit 2B) ramp
  - Continue north on NW 3 Avenue to connect with NW 8 Street
- TUESDAY, JULY 7 THROUGH FRIDAY, JULY 10 - The North Bayshore Drive ramp lane to eastbound MacArthur Causeway will be closed between the hours of 9 p.m. and 5 a.m.  
DETOUR:
  - Turn right on NE 13 Street, then turn left on Biscayne Boulevard
  - Turn right on NE 11 Street, then turn left on NE 2 Avenue
  - Turn left on NE 10 Street, then turn left on Biscayne Boulevard to access the ramp to MacArthur Causeway
