### **SR A1A/MACARTHUR CAUSEWAY AT SR 907/ALTON ROAD**

FIN #: 431635-1-52-01

#### **LANE CLOSURES:**

- A partial lane closure of the eastbound MacArthur Causeway right turn lane onto southbound Alton Road will be necessary for one day from 9 a.m. to 3:30 p.m. along eastbound MacArthur Causeway when approaching Alton Road. This closure will allow crews to finalize the work. An exact date for this operation is pending to be determined.
- A flashing beacon has been installed along eastbound MacArthur Causeway when approaching Alton Road. The flashing beacon activates and alerts drivers when the traffic signal located at Alton Road is red for eastbound MacArthur Causeway traffic.

### **SR A1A/SR A1A/MACARTHUR CAUSEWAY AT FOUNTAIN STREET**

FIN #: 431635-1-52-01

#### **LANE CLOSURES:**

- A temporary single lane closure will be necessary for one day from 9 a.m. to 3:30 p.m. along MacArthur Causeway when approaching Fountain Street. This closure will allow crews to finalize the work. The exact date for this operation is pending to be determined.
- Flashing beacons are being installed along eastbound and westbound MacArthur Causeway when approaching Fountain Street. Once the project is complete, the flashing beacons activate and alert drivers when the traffic signal located at Fountain Street is red for eastbound and westbound MacArthur Causeway traffic.

### **SR 907/ALTON RD FROM 6 ST TO 20 ST AND SR 934/NORMANDY DRIVE FROM E BAY DR TO W BAY DR**

#### **LANE CLOSURES:**

- One eastbound or one westbound lane may be partially closed along Normandy Drive from Bay Drive West to Bay Drive East between 9 a.m. and 3:30 p.m. Monday through Thursday.
- The northbound outside lane along Alton Road between 6 street and 20 Street will be closed from 9 a.m. to 3:30 p.m.

## INDIAN CREEK DRIVE FLOODING MITIGATION PROJECT

### LANE CLOSURE

- Indian Creek Drive continues to be closed to general traffic between 41 Street and 31 Street while the contractor installs underground drainage and rebuilds the roadway. Southbound traffic is being routed to Collins Avenue in this area. Collins Avenue has been modified to provide one northbound and one southbound travel lane. This traffic pattern is expected to last about one year.
- One southbound lane on Indian Creek Drive is closed during daytime hours between 28 Street and 26 Street while the contractor performs drainage and sidewalk work. One lane will remain open at all times. A pedestrian detour will be set up as needed during the work. This work is expected to last several weeks.

## I-395 RECONSTRUCTION PROJECT

### LANE CLOSURES:

- FRIDAY, SEPTEMBER 4 AND TUESDAY, SEPTEMBER 8 THROUGH SATURDAY, SEPTEMBER 12 - Up to four lanes on northbound I-95 will be closed nightly from NW 8 Street to NW 29 Street between the hours of 8 p.m. and 5:30 a.m. One outside, northbound I-95 lane between NW 23 Street and NW 29 Street and Exit 4A to I-195 east will remain continuously closed until 5:30 a.m. on Wednesday, September 9. Drivers can continue north on I-95 and access Exit 4B to go east on I-195. Closures on Friday and Saturday will occur between the hours of 8 p.m. and 11 a.m.
- FRIDAY, SEPTEMBER 4 AND TUESDAY, SEPTEMBER 8 THROUGH SATURDAY, SEPTEMBER 12 - Up to four lanes on southbound I-95 from NW 29 Street to NW 8 Street will be closed between the hours of 8 p.m. and 5:30 a.m. Closures on Friday and Saturday will occur between the hours of 8 p.m. and 11 a.m.
- FRIDAY, SEPTEMBER 4 AND TUESDAY, SEPTEMBER 8 THROUGH SATURDAY, SEPTEMBER 12 - Two lanes on eastbound SR 836 from NW 20 Avenue to east of NW 17 Avenue will be closed between the hours of 9 p.m. and 5:30 a.m. One lane will also be closed between the hours of 9:30 a.m. and 3:30 p.m. from NW 17 Avenue to NW 12 Avenue. On Friday, September 4, two lanes will be closed between the hours of 10 p.m. and 5:30 a.m.
- FRIDAY, SEPTEMBER 4 AND TUESDAY, SEPTEMBER 8 THROUGH SATURDAY, SEPTEMBER 12 - Two westbound lanes on SR 836 from I-95 to NW 17 Avenue will be closed between the hours of 9 p.m. and 7 a.m. Closures on Fridays will be implemented between the hours of 10 p.m. and 8 a.m. One lane will also be closed between the hours of 7 a.m. and 2 p.m. from NW 17 Avenue to NW 12 Avenue. On Friday, September 4, two lanes will be closed between the hours of 10 p.m. and 8 a.m.
- TUESDAY, SEPTEMBER 8 THROUGH SATURDAY, SEPTEMBER 12 - One lane on mainline eastbound I-395 will be closed from I-95 to Biscayne Boulevard between the hours of 8 p.m. and 5:30 a.m.
- TUESDAY, SEPTEMBER 8 THROUGH SATURDAY, SEPTEMBER 12 - One lane on mainline westbound I-395 will be closed from I-95 to Biscayne Boulevard between the hours of 8 p.m. and 5:30 a.m.

## DETOURS:

- FRIDAY, SEPTEMBER 4 - The northbound I-95 ramp to eastbound I-395 will be closed between the hours of 9 p.m. and 5:30 a.m.  
DETOUR:
  - Exit at the NW 2 Street ramp (Exit 2B)
  - Continue north on NW 3 Avenue, then turn right on NW 8 Street
  - Continue east on NW/NE 8 Street
  - Turn left on Biscayne Boulevard to access A1A North/Miami Beach
- FRIDAY, SEPTEMBER 4 AND TUESDAY, SEPTEMBER 8 THROUGH SATURDAY, SEPTEMBER 12 - The westbound I-395 ramp to southbound I-95 will be closed between the hours of 9 p.m. and 5:30 a.m.  
DETOUR:
  - Go north on I-95, then exit at NW 62 Street
  - Turn left at NW 62 Street to access the southbound I-95 ramp
- FRIDAY, SEPTEMBER 4 AND TUESDAY, SEPTEMBER 8 THROUGH SATURDAY, SEPTEMBER 12 - The eastbound SR 836 ramp to southbound I-95 will be closed between the hours of 9 p.m. and 5:30 a.m.  
DETOUR:
  - Access the ramp to NW 8 Street
  - Continue south on NW 3 Court to access the I-95 south ramp after NW 2 Street
- FRIDAY, SEPTEMBER 4 AND TUESDAY, SEPTEMBER 8 THROUGH SATURDAY, SEPTEMBER 12 - The NW 8 Street ramp to northbound I-95 will be closed as needed between the hours of 8 p.m. and 5:30 a.m.  
DETOUR:
  - Go east on NW 5 Street, then turn left at NE 1 Avenue
  - Access the westbound I-395 entrance ramp to I-95 north
- TUESDAY, SEPTEMBER 8 THROUGH SATURDAY, SEPTEMBER 12 - The eastbound SR 836 ramp to northbound I-95 will be closed between the hours of 9 p.m. and 5:30 a.m.  
DETOUR:
  - Continue east on I-395, then exit at the Biscayne Boulevard Ramp (Exit 2A)
  - Turn right on NE 2 Avenue, then turn right on NE 11 Street
  - Turn right on NE 1 Avenue to access the I-95 North Ramp.
- TUESDAY, SEPTEMBER 8 THROUGH SATURDAY, SEPTEMBER 12 - All northbound I-95 lanes will be closed at the eastbound I-395 ramp between the hours of 9:30 p.m. and 5:30 a.m. to allow the project contractor to replace the concrete pavement. The northbound I-95 ramp to westbound SR 836 will remain open during this time frame. The closures on Friday and Saturday will be implemented between the hours of 11 p.m. and 8:30 a.m.  
DETOUR:
  - Access the eastbound I-395 ramp
  - Exit at the Biscayne Boulevard ramp (Exit 2B)
  - Turn right on NE 2 Avenue, then turn right on NE 11 Street
  - Turn right on NE 1 Avenue to access the I-95 north ramp
- THURSDAY, SEPTEMBER 10 THROUGH SATURDAY, SEPTEMBER 12 - The eastbound SR 112 and westbound I-195 ramps to southbound I-95 will be closed as needed between the hours of 9 p.m. and 5:30 a.m.  
DETOUR:
  - Continue north on I-95 and exit at NW 62 Street

- Turn left at NW 62 Street to access the southbound I-95 ramp
