
THIS DOCUMENT INCLUDES FDOT SCHEDULED CONSTRUCTION-RELATED LANE CLOSURES ON STATE ROADS, FOR CORRIDORS TO/FROM AND IN MIAMI BEACH.

FRIDAY, 10/13/2023 TO FRIDAY, 10/20/2023

SR A1A/COLLINS AVENUE AT 10, 11, 14, AND 74 STREET

LANE CLOSURES:

- At least one northbound and/or southbound lane of SR A1A/Collins Avenue at the intersections of 10, 11, 14, and 74 Street will be closed (as needed) between the hours of 9 a.m. and 3:30 p.m., weekdays and weekends. 9 p.m. to 5:30 a.m., Sunday through Thursday nights, and 11 p.m. to 7 a.m., Friday and Saturday nights.

SR A1A/COLLINS AVENUE/INDIAN CREEK DRIVE FROM 5800 BLOCK TO SR 907/63 STREET

LANE CLOSURES:

- One lane may be closed between 8 a.m. and 3:30 p.m. on the east side of Collins Avenue between the 5800 block and 63 Street, as needed.

SR A1A/ MACARTHUR CAUSEWAY FROM SR 5/US/BISCAYNE BOULEVARD TO SR 997/ALTON ROAD

LANE CLOSURES:

- One eastbound lane from Biscayne Boulevard to Fountain Street may be closed from 9 PM to 6 AM.

LANE CLOSURES:

- Beginning the night of Wednesday, May 31 one lane may be closed between 9 p.m. and 5:30 a.m. for drainage operations.

I-395 RECONSTRUCTION PROJECT

LANE CLOSURES:

- FRIDAY, OCTOBER 13 AND SUNDAY, OCTOBER 15 THROUGH FRIDAY, OCTOBER 20 - Up to four lanes on southbound I-95 from NW 29 Street to NW 8 Street will be closed as needed between the hours of 9 p.m. and 5:30 a.m. Closures on Fridays will be implemented between the hours of 11 p.m. and 11 a.m.

- FRIDAY, OCTOBER 13 AND SUNDAY, OCTOBER 15 THROUGH FRIDAY, OCTOBER 20 - Up to four lanes on northbound I-95 will be closed as needed from NW 8 Street to NW 29 Street between the hours of 9 p.m. and 5:30 a.m. Closures on Fridays will be implemented between the hours of 11 p.m. and 11 a.m.
- FRIDAY, OCTOBER 13 AND SUNDAY, OCTOBER 15 THROUGH FRIDAY, OCTOBER 20 - One lane on mainline eastbound I-395 will be closed as needed from I-95 to Biscayne Boulevard between the hours of 10 p.m. and 5:30 a.m.
- FRIDAY, OCTOBER 13 AND SUNDAY, OCTOBER 15 THROUGH FRIDAY, OCTOBER 20 - Up to two lanes on mainline westbound I-395 will be closed as needed from Biscayne Boulevard to I-95 between the hours of 10 p.m. and 5:30 a.m.
- FRIDAY, OCTOBER 13 AND SUNDAY, OCTOBER 15 THROUGH FRIDAY, OCTOBER 20 - Two eastbound lanes on SR 836 from NW 17 Avenue to I-95 will be closed as needed for bridge work between the hours of 9 p.m. and 5:30 a.m.
- FRIDAY, OCTOBER 13 AND SUNDAY, OCTOBER 15 THROUGH FRIDAY, OCTOBER 20 - Two westbound lanes on SR 836 from I-95 to NW 17 Avenue will be closed as needed for bridge work between the hours of 9 p.m. and 5:30 a.m.
- Starting at 9 p.m. on Friday, October 13, until 7 p.m. on Saturday, October 14, the project contractor will be pouring concrete at the arch foundation shown in the photo above. The following closures will be implemented to allow the approximately 360 trucks to deliver concrete to the site safely.

UPDATED DETOUR INFORMATION:

- At 9 p.m. on Friday, October 13, until 7 p.m. on Saturday, October 14, all lanes on southbound North Bayshore Drive will be closed from NE 14 Street to NE 13 Street.
 - Drivers on southbound North Bayshore Drive can turn right on NE 15 Street to connect with Biscayne Boulevard
- At 9 p.m. on Friday, October 13, one left lane on NE 13 Street will be closed from North Bayshore Drive to Biscayne Boulevard, then at 11:30 p.m., all lanes on NE 13 Street will be closed as shown above until 7 p.m. on Saturday, October 14. Drivers can:
 - Turn right on northbound North Bayshore Drive
 - Turn left on NE 14 Street or NE 15 Street to connect with Biscayne Boulevard

DETOURS:

- SUNDAY, OCTOBER 15 THROUGH FRIDAY, OCTOBER 20 - The northbound I-95 ramp to westbound SR 836 will be closed between the hours of 10 p.m. and 5:30 a.m. for lighting maintenance.

Drivers can:

- Enter the eastbound I-395 ramp
- Exit at NE 2 Avenue/Biscayne Boulevard (Exit 2B), then turn right on NE 2 Avenue
- Turn right on NE 11 Street
- Turn right on NE 1 Avenue to access westbound I-395 to continue onto westbound SR 836

- SUNDAY, OCTOBER 15 - The northbound I-95 ramp to eastbound I-395 will be closed between the hours of 10 p.m. and 5:30 a.m. Drivers can:

DETOUR

- Exit at the NW 2 Street ramp (Exit 2B)
- Continue north on NW 3 Avenue, then turn right on NW 8 Street
- Continue east on NW/NE 8 Street
- Turn left on Biscayne Boulevard to access A1A North/Miami Beach

- MONDAY, OCTOBER 16 THROUGH FRIDAY, OCTOBER 20 - The eastbound SR 836 ramp to northbound I-95 will be closed as needed between the hours of 9 p.m. and 5:30 a.m. Drivers can:

DETOUR

- Access the southbound I-95/NW 8 Street ramp, then exit at the NW 8 Street/PortMiami ramp
- Turn left at NW 8 Street
- Turn left at NW 3 Avenue to access the northbound I-95 ramp

- MONDAY, OCTOBER 16 - The southbound I-95 ramp to eastbound I-395 will be closed as needed between the hours of 11:45 p.m. and 5:30 a.m. Drivers can:

DETOUR

- Continue south on I-95, exit at the NW 8 Street ramp (Exit 3B)
- Turn left on NW 8 Street, continue east on NW 8 Street
- Turn left at Biscayne Boulevard to access the A1A North/Miami Beach Ramp

- TUESDAY, OCTOBER 17 (WEDNESDAY, OCTOBER 18 IS AN ALTERNATE DATE) - All eastbound SR 836 lanes will be closed from NW 17 Avenue to NW 12 Avenue between the hours of 10 p.m. and 5:30 a.m.

Drivers on eastbound SR 836 can:

- Exit at the NW 17 Avenue South (Ballpark) ramp, then turn right at NW 17 Avenue
- Turn left at NW 7 Street
- Turn left at NW 12 Avenue to connect with eastbound SR 836 ramp

- WEDNESDAY, OCTOBER 18 (THURSDAY, OCTOBER 19 IS AN ALTERNATE DATE) - All westbound SR 836 lanes will be closed from NW 12 Avenue to NW 17 Avenue between the hours of 10 p.m. and 5:30 a.m.

Drivers on westbound SR 836 can:

- Exit at the NW 12 Avenue ramp, then turn left on NW 12 Avenue
- Turn right on NW 7 Street
- Turn right on NW 27 Avenue and continue north to connect with the westbound SR 836 ramp

- WEDNESDAY, OCTOBER 18 - The southbound I-95 ramp to eastbound I-395 and all southbound I-95 lanes will be closed at SR 836 between the hours of 11:45 p.m. and 5:30 a.m. Drivers can use the detour routes below.

Non-Tolled detour route for southbound I-95:

- Exit at the SR 836 West Ramp, then exit at NW 14 Street
- Turn left at NW 12 Avenue, then turn left at NW 11 Street
- Turn right at NW 8 Street Road, then turn left at NW 8 Street
- Turn right at NW 3 Court to access the I-95 south ramp after NW 2 Street

Non-Tolled detour route for eastbound I-395:

- Exit at the SR 836 West Ramp, then exit at NW 14 Street
- Turn left at NW 12 Avenue, then turn left at NW 11 Street
- Turn right at NW 8 Street Road, then turn left at NW 8 Street
- Continue east on NW 8 Street, then turn left at Biscayne Boulevard to access the A1A North/Miami Beach ramp

Tolled detour route for southbound I-95:

- Exit at the SR 836 West Ramp, then exit at NW 12 Avenue
- Turn left at NW 12 Avenue to access the SR 836 east entrance ramp
- Continue east on SR 836 to access the I-95 south ramp

Tolled detour route for eastbound I-395:

- Exit at the SR 836 West Ramp, then exit at NW 12 Avenue
- Turn left at NW 12 Avenue to access the SR 836 east entrance ramp
- Continue east on SR 836 to access eastbound I-395
